Thank you for participating in Big Day of Giving 2021, the community-wide effort that raised \$13.3 million for 688 local nonprofits—including Bradshaw Animal Shelter / TEAM Bradshaw.

I am writing to alert to you that your Big Day of Giving funds will be emailed to you in the coming days via an electronic eCheck. The eCheck will be in the amount of **\$33,059.83**, made out to **Teaching Everyone Animals Matter**, and is intended as **unrestricted**.
